### 52. Gambling Act 2005 Triennial Review of Statement of Licensing Policy

The Licensing Team Leader:

- a. presented a report to update Licensing Committee on the result of the consultation on the Statement of Licensing Policy (the Policy) under the Gambling Act 2005 ('the Act')
- b. advised that if approved at Licensing Committee members were asked to forward the policy to Full Council for adoption.
- c. informed members that the Act required the Licensing Authority to publish its Statement of Licensing Policy at least every three years, which in this case must be published by 31 January 2019
- d. highlighted that the draft policy had been forwarded to 51 persons/organisations, and all members of Licensing Committee as part of the consultation process.
- e. advised that there had been five responses resulting from the consultation process as detailed at paragraph 4 and associated appendices to the report

- f. detailed minor amendments made to the policy as a result of the consultation process also covered within paragraph 4 of the officers report
- g. invited members' questions and comments.

Members discussed the content of the report in further detail.

Members queried whether proposed changes in parliament to reduce the maximum stakes for Fixed Odds Betting Terminals may result in the policy having to be referred back to Licensing Committee for amendment.

The Licensing Team Leader confirmed that:

- A link was provided within the City of Lincoln Statement of Policy to the Gambling Commission's official website which was regularly updated to accommodate any legislative changes.
- The Licensing Authority would need to monitor any potential negative impact on the wellbeing of members of the public in the event that stakes on fixed odds betting terminals were drastically reduced and betting shops turned their focus to new 'income streams' to compensate for loss of earnings.

# 14. <u>To Interview an Applicant for a Private Hire Driver's Licence who is Unable to</u> Provide a Certificate of Good Conduct (01/2019)

The Licensing Officer:

- a) explained that the applicant came into City Hall for an appointment to apply for a new Hackney Carriage Drivers Licence on 24 August 2018
- b) highlighted that the applicant had been unable to provide the Licensing Team with a certificate of good conduct from Afghanistan where he was originally from
- c) stated that the applicant came to the UK in 2009
- d) highlighted that the applicant had held a full UK driving licence since October 2013
- e) explained that the applicant passed the knowledge test on his second attempt as well as achieving a low risk on the Driver Improvement Programme.

Members asked the applicant relevant questions in relation to his application

#### Decision

That the Private Hire Drivers licence be granted

#### Reasons for the Decision

- The applicant had a clean drivers licence and DBS check
- The applicant was very pleasant and presentable
- The applicant was currently employed within the City
- The applicant came to the UK aged 15 as a refugee

### 17. <u>Exclusion of Press and Public</u>

RESOLVED that the press and public be excluded from the meeting during consideration of the following item(s) of business because it is likely that if members of the public were present there would be a disclosure to them of 'exempt information' as defined by Section 100I and Schedule 12A to the Local Government Act 1972.

# 18. <u>To Interview an Existing Driver who has 9 Current Penalty Points</u>

The Licensing Officer:

- a) Stated that the licensee had held a private hire drivers licence since December 2015.
- b) Explained that the licensee came into City Hall for a re-licence appointment on Monday 22 November 2018.
- c) Explained that the licensee was asked during his re-licence appointment whether he had received any convictions or criminal findings of guilt such as fixed penalty notices. The licensee then disclosed that he had received 6 points for failing to give information as to the identity of a driver, an offence which occurred on 13 November 2017, and 3 points for a speeding offence, an offence which occurred on 1 May 2018.
- a) Stated that the licensee did not disclose his offences to the licensing team until his renewal application came around. This meant that the driver was in contravention of Condition 10 of his licence conditions, which requires the licensee to inform the Licensing Authority in writing of any criminal findings of guilt immediately after the date of conviction, including fixed penalty tickets.

The Sub-Committee questioned the licence holder about his offences and his failure to inform the Licensing Authority.

For the offence of failure to give information as to the identity of the driver, the licensee explained that his partner had just had a baby and he had changed

address, hence the letter went to his old address. He eventually went to court for the offence in August 2018 and was fined and issued with 6 penalty points.

The licence holder responded that for the offence of exceeding the statutory speed limit on a public road, he had made a genuine mistake on a stretch of road with average speed camera restrictions. He had not realised that the road suddenly went from 50 mph to 40 mph and he had exceeded the average speed limit.

### Decision

That the Private Hire Vehicle Driver's Licence be granted with the condition that the licensee be sent a warning letter to remind him of his responsibilities and of the conditions of his licence.

### Reasons for the Decision

- 1. The Sub-Committee believed that the licence holder was genuinely remorseful for his behaviour.
- 2. The licensee had been distracted at the time of the first offence by a lot going on in his personal life with the delivery of a new baby.
- 3. The licensee had been punished by being unable to carry-on his trade since 10 December 2018 as his licence could not be renewed until the Sub-Committee had heard the case.
- 4. The Sub-Committee believed that the licensee was truly remorseful and that it was extremely unlikely that he would re-offend as this job was vital to him being able to support his family.

# 19. <u>To Interview an Applicant for a Private Hire Driver's Licence who has Failed to</u> Disclose a Previous Offence

The Licensing Officer:

- a) Explained that the licensee came into City Hall to apply for a new Private Hire Vehicle Driver's Licence on Monday 7 November 2018.
- b) Explained that the licensee was asked during his application appointment whether he had received any convictions or criminal findings of guilt such as fixed penalty notices. The applicant said he had no convictions and failed to disclose a simple caution which had been issued to him for using threatening, abusive, insulting words or behaviour with intent to cause fear or provocation of violence, an offence which occurred on 23 June 2017. This conviction was discovered upon sight of the DBS.

The Sub-Committee questioned the applicant about his offence. The applicant responded that he was not aware that he had been issued with a simple caution whilst he was held at the police station. The applicant explained that he had been defending his work colleagues who were being threatened during a social evening, which resulted in a fracas to which the police had been called. The applicant said he had confronted the police regarding the arrest of a work colleague, which he felt was unjust. This subsequently led to the applicant also being arrested and issued with a simple caution, although he was unaware that

this had happened until the DBS check was returned as part of his licence application.

### Decision

That the Private Hire Vehicle Driver's Licence be granted.

### **Reasons for the Decision**

- The applicant gave a plausible and reasonable explanation for the events that led to him being issued with a simple caution and for his lack of awareness that a simple caution had been issued until his DBS check was returned.
- 2. A simple caution was on the very lowest end of the scale of possible disposals for such an offence, which was an indication that whatever had happened was very minor.
- 3. The applicant produced evidence to the Sub-Committee of his exemplary behaviour and good conduct during the course of his employment as a manager in the hospitality industry for a number of years previously. This persuaded the Sub-Committee that the applicant was familiar with difficult customer interactions, which they considered would be of benefit in his employment as a licensed Private Hire Vehicle Driver.
- 4. The Sub-Committee believed that the applicant was truly remorseful and that it was extremely unlikely that he would re-offend.

SUBJECT: LICENSING ACT 2003 – DETERMINING FILM CLASSIFICATIONS

DIRECTORATE: COMMUNITIES AND ENVIRONMENT

### 1. Purpose of Report

1.1 To seek an indication on the Committee's views in regards to the certification of films not already classified by The British Board of Film Classification (BBFC).

### 2. Executive Summary

2.1 To seek approval from the Licensing Committee in regards to creating a scheme of delegation in determining requests to certify films not already classified by the BBFC.

### 3. Background

- 3.1 The Council has received a request to certify a short film, which is to be shown in multiple locations within the district. This is a requirement of the Council because the film has not been classified by the BBFC.
- 3.2 Mr Richard Hall, on behalf of the Lincoln Film Society, has requested the Council to classify the film 'Born a Rebel'. Mr Hall has submitted a synopsis of the film, which can be seen at Appendix A.
- 3.3 Mr Hall has also submitted a letter from North Somerset Council who certified 'Born A Rebel' 12A in February this year, a copy of this letter can be seen at Appendix B.

### 4. Legislation

- 4.1 The Licensing Act 2003 (the Act) deals with the exhibition of films as 'regulated entertainment'. This means that when a film is shown to entertain an audience and either takes place in the presence of a public audience or, if in private, with a charge made with a view to profit, the activity is licensable. As a result, the premises will need to hold a Premises Licence, Club Premises Certificate or a Temporary Event Notice (TEN).
- 4.2 Additionally, a community premises can now benefit from an exemption in specific situations, which means that they can show films without requiring a Premises Licence, Club Premises Certificate or a TEN.

4.3 When a film is shown in a premises which has a Premises Licence, Club Premises Certificate or is a premises considered 'exempt' (i.e. a community premises), the following condition applies:

No children shall be admitted to the exhibition of any film unless they have reached the age specified in the BBFC Certificate, or the Classification issued by the Licensing Authority.

- The majority of commercial films are classified by the BBFC who essentially rate films on behalf of Local Authorities, with the Local Authority then licensing premises to show films under the Licensing Act 2003. However, on some occasions people request that a film is classified by the Local Authority.
- 4.5 In most cases these films are relatively small scale, made regionally and the cost of having the film classified by the BBFC is prohibitive. As a result, Local Authorities are requested to classify the film.

### 5. Current Policy

5.1 Currently the Council does not have a policy for determining film classifications and this function does not feature in the scheme of delegations attached to the statement of licensing policy.

### 6. Considerations

- When considering the classification of a film, the Council must have regard to the Licensing Act 2003, which requires the Licensing Authority to carry out its functions with a view to promoting the 4 licensing objectives, which are:
  - The Prevention of Crime and Disorder;
  - Public Safety;
  - The Prevention of Public Nuisance; and
  - The Protection of Children from Harm
- 6.2 The most relevant objective in relation to these matters is the Protection of Children from Harm.
- In carrying out its licensing functions, the Licensing Authority must have regard to its Statement of Licensing Policy and Guidance issued under S182 of the Licensing Act. A copy of both of these documents will be made available at the hearing.
- Paragraph 5.5 of the Statement of Licensing Policy covers the Protection of Children from Harm. The Policy does not currently cover the classification of films in detail and this will be reviewed by the Licensing Team in due course.
- 6.5 Section 182 Guidance issued under the Licensing Act contains some information which is particularly relevant to these decisions and this is highlighted below:

The protection of children from harm includes the protection of children from moral, psychological and physical harm. This includes not only protecting

children from the harms associated directly with alcohol consumption but also wider harms such as exposure to strong language and sexual expletives (for example, the context of exposure to certain films or adult entertainment). Licensing authorities must also consider the need to protect children from sexual exploitation when undertaking licensing functions. (Paragraph 2.22)

The 2003 Act provides that where a premises licence or club premises certificate authorises the exhibition of a film, it must include a condition requiring the admission of children to films to be restricted in accordance with recommendations given either by a body designated under section 4 of the Video Recordings Act 1984 specified in the licence (currently only the British Board of Film Classification [BBFC]) or by the licensing authority itself. (Paragraph 10.59)

### 7. British Board of Film Classification (BBFC)

7.1 In terms of guidance on how to classify a film, it is recommended that the Council use 'The British Board of Film Classification Guidelines'. A copy of this will be provided at the hearing

### 8. Delegated Authority

- 8.1 The purpose of this report is not for the Committee to determine a certification for the film 'Born a Rebel' today but to determine whether to delegate authority for this decision to the Licensing Sub-Committee or to Licensing Officers. Alternatively, the Committee may decide to keep the authority with the full Licensing Committee.
- 8.2 If the Committee is minded to either keep the authority with the full Licensing Committee or to delegate to the Licensing Sub-Committee then it is recommended that members receive formal training before determining any requests.

### 9. Options

- 9.1 The Licensing Committee has the following options in regards to the determination of requests to certify films not classified by the BBFC:
  - To delegate authority to Licensing Officers, (with referral to Licensing Sub-Committee/Licensing Committee if deemed necessary)
  - To delegate authority to the Licensing Sub-Committee
  - To keep the authority with the Licensing Committee
- 9.2 If the authority is kept with the Licensing Committee or the authority is delegated to the sub-committee then it is recommended that before any requests are determined, adequate member training be completed.

### 10. Organisational Impacts

10.1 Legal Implications

- The applicant has a right of appeal if he is unhappy with the decision made.
- 10.3 Finance
- 10.4 Any costs associated with member training or an appeal will be met via existing financial resources.

### 11. Recommendation

11.1 Members are required to make a determination as outlined in paragraph 9.1 above.
