The Mayor read out the following motion:

To consider the following recommendation from the meeting of Council on 3 December 2024, pursuant to Section 249 of the Local Government Act 1972.

That the Council do resolve as follows:

"That the Mayor and Citizens of the City of Lincoln do confer the Honorary Freedom of the City upon Robin Bradley in recognition of his outstanding contribution to the City, by being instrumental in support of Lincoln City Football Club, having worked tirelessly to help keep the Club operating through turbulent times.
