NOTES

- 1. The Leader in consultation with the Chief Executive and Town Clerk prepares an Executive Work Programme to cover a period of twelve months.
- 2. The Executive Work Programme contains matters which the Leader has reason to believe will be the subject of a key decision during the period covered by the Plan or Executive decisions which are likely to be taken in private.
- 3. A Key Decision is one which is likely:
 - to result in the Local Authority incurring expenditure which is, or the making of savings which are, significant having regard to the Local Authority's budget for the service or function to which it relates; or
 - b) to be significant in terms of its effect on communities living or working in an area comprising 2 or more wards in the area of the local authority.
- 4. While the majority of the Executive's business at the meetings listed in the Executive Work Programme will be open for the public to attend, there may be some business to be considered that contains, for example, confidential, commercially sensitive or personal information.

This document serves as formal notice under the Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012 that certain items in the Executive Work Programme will be considered in private because the item contains exempt information under Schedule 12A to the Local Government Act 1972 and that the public interest in withholding the information outweighs the public interest in disclosing it. If an item is to be considered in private this will be indicated on the individual decision notice.

Any key or private decisions for which the requisite 28 days' notice has not been given will be listed on the Council's website and made available at City Hall
