This is the matter for the courts. The licensing authority's role when determining such a review is not therefore to establish guilt or innocence of any individual but to ensure the promotion of the crime prevention objective. |

| 11.25 Reviews are part of the regulatory process introduced by the 2003 Act and they are not part of criminal law and procedure. There is, therefore, no reason why representation giving rise to a review of a premise licence need to be delayed pending the outcome of any criminal proceedings. Some reviews will arise after conviction in the criminal courts of certain individuals, but not all. In any case it is for the licensing authority to determine whether the problem associated with alleged crimes are taking place on the premises and affecting the promotion of the licensing objectives. Where a review follows a conviction, it would also not be for the licensing authority to attempt to go beyond any finding by the courts, which should be treated as a matter of undisputed evidence before them. |

At approximately 03:05 hours on Monday 27<sup>th</sup> March 2017, staff and management from the premises have become involved in a serious offence of assault using weapons, leading to GBH (Grievous Bodily Harm) and ABH (Actual Bodily Harm) injuries. Owing to this being part of an ongoing investigation, full details are subject to Regulation 14. Please see Appendix A - Statement of PC 80 Birch for full details. This statement also details any further relevant information held on Lincolnshire Police systems for the premise and licence holder.

On 28<sup>th</sup> March 2017, officers from Lincolnshire Police conducted a licensing check at the premises, following the above incident. Officers spoke to the Mr Yilmaz, who confirmed that the CCTV was not working owing to Police having seized the hard drive for the above incident. He also admitted that there was no panic alarm installed, as per Annex C of the premise licence. The premises licence was on display, however when conditions were pointed out to him, he stated that he had 'not read the conditions', showing a complete disregard for maintaining the licensing objectives.

Topkapi is clearly a family run business, and Mr Yusef Yilmaz was named as the Premises Licence Holder in January 2017, following the transfer of the licence from family member Kubilay Yilmaz. The premises has a history of having an aggressive attitude and a complete disregard for maintaining the licensing objectives, leading to a number of Police reviews and representations being submitted for other named family members. This behaviour and attitude appears to have been duplicated in the current premises licence holder's behaviour, and the continued behaviour of the staff and management of the staff within the premises.

Licensed for late night refreshments, staff are routinely likely to come into contact with individuals under the influence of alcohol, who may be more animated in their behaviour. Lincolnshire Police question how any response with knives, weapons and extreme aggression and intimidating behaviour can be seen as proportionate and appropriate.

Lincolnshire Police feel that it is a necessary and proportionate response to request a review of the Premises Licence. Lincolnshire Police feel that the revocation of the licence should be given full consideration owing to the serious violence having been displayed by the management and staff of the premise. This aggressive and uncooperative behaviour shows a complete disregard and undermining of the licensing objectives.
