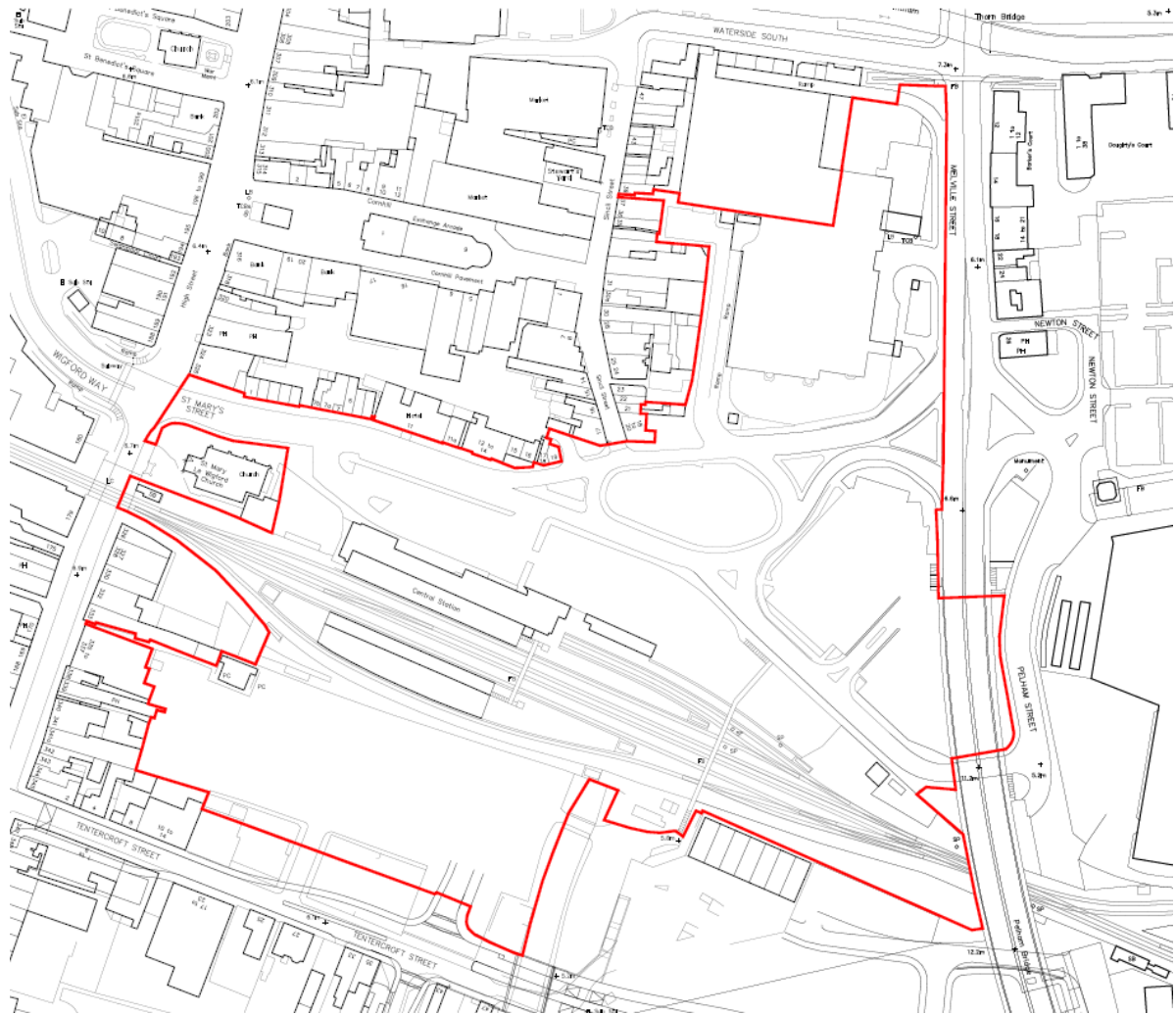


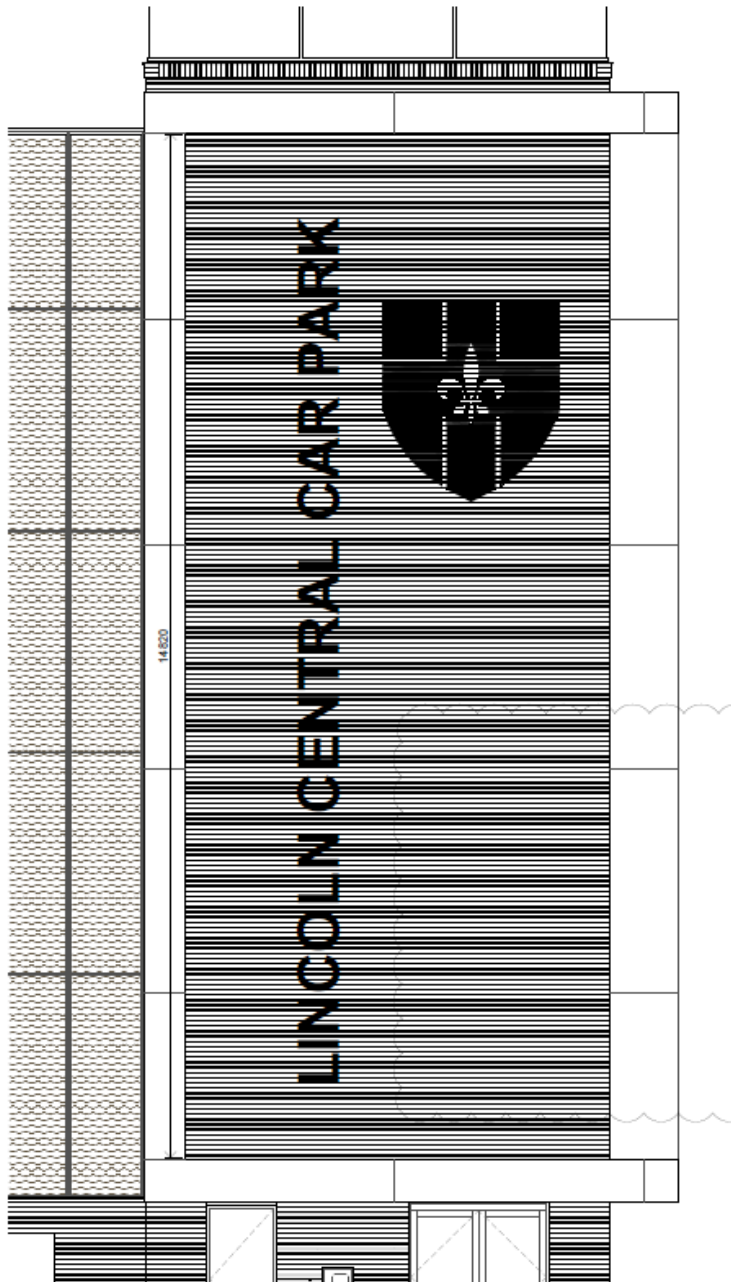
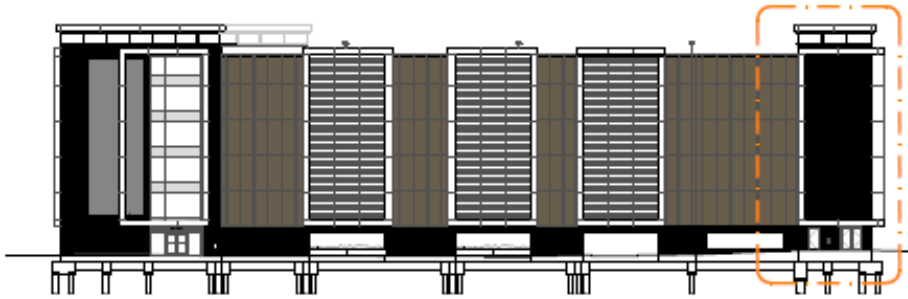

Site Location Plan

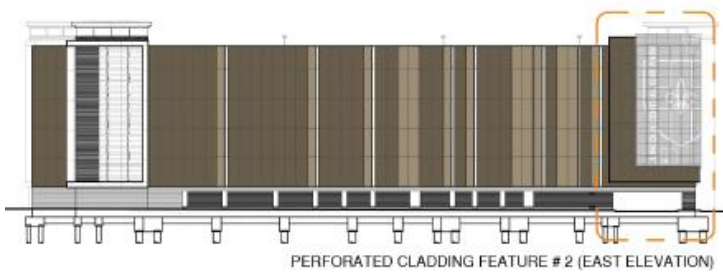

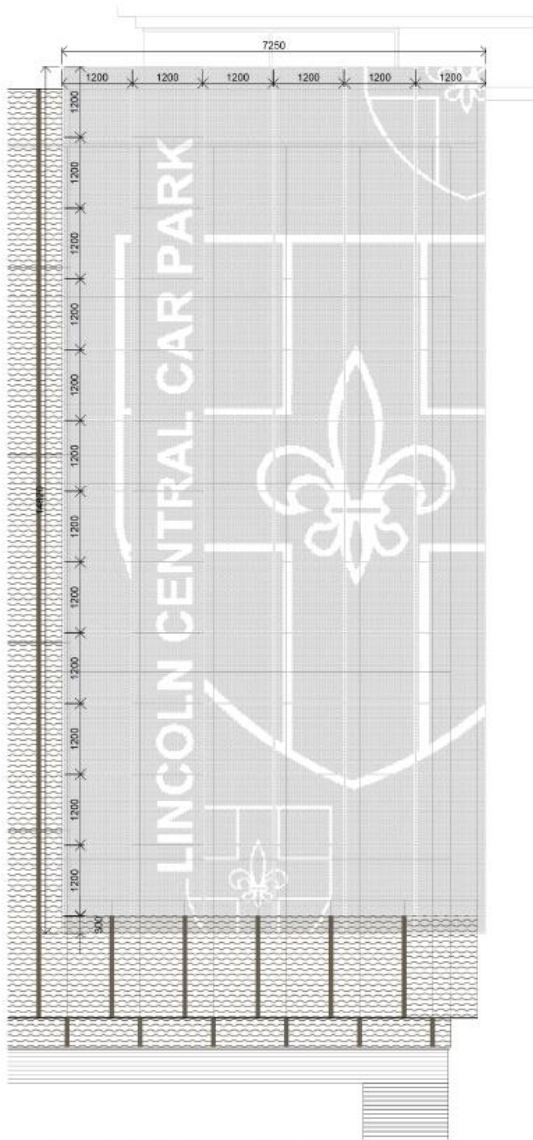
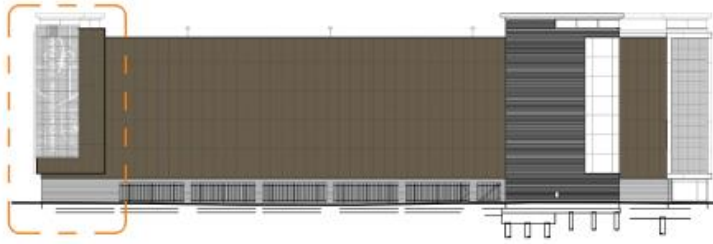
MSCP South Elevation



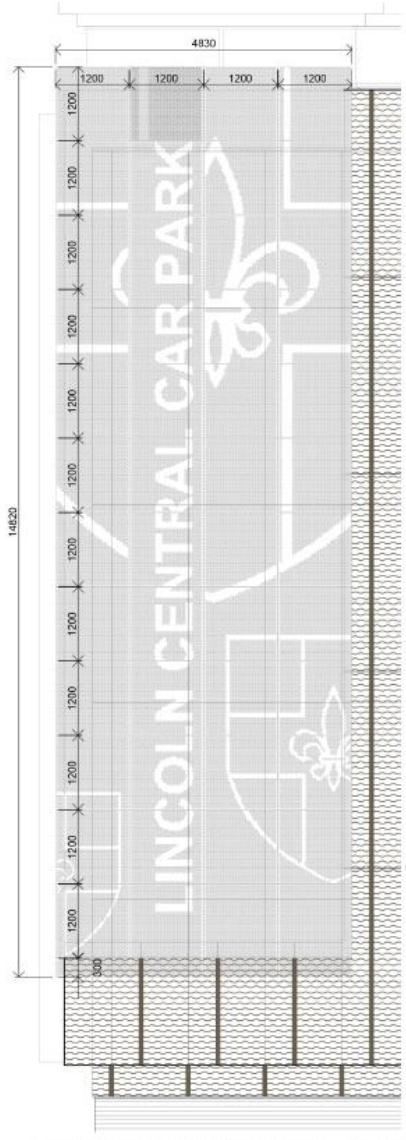
MSCP East/North Elevations



PERFORATED CLADDING FEATURE # 2 (EAST ELEVATION)

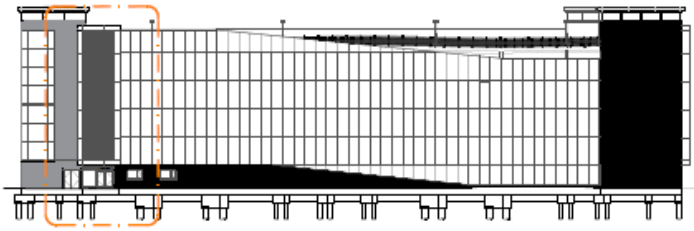


PERFORATED CLADDING FEATURE # 2 (EAST ELEVATION)

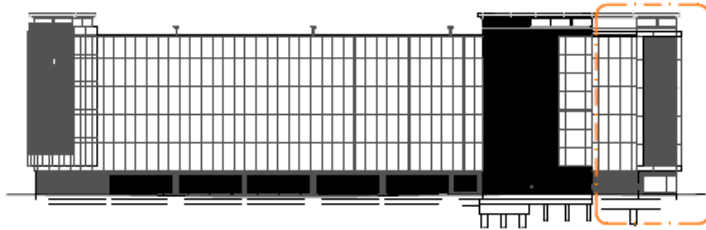

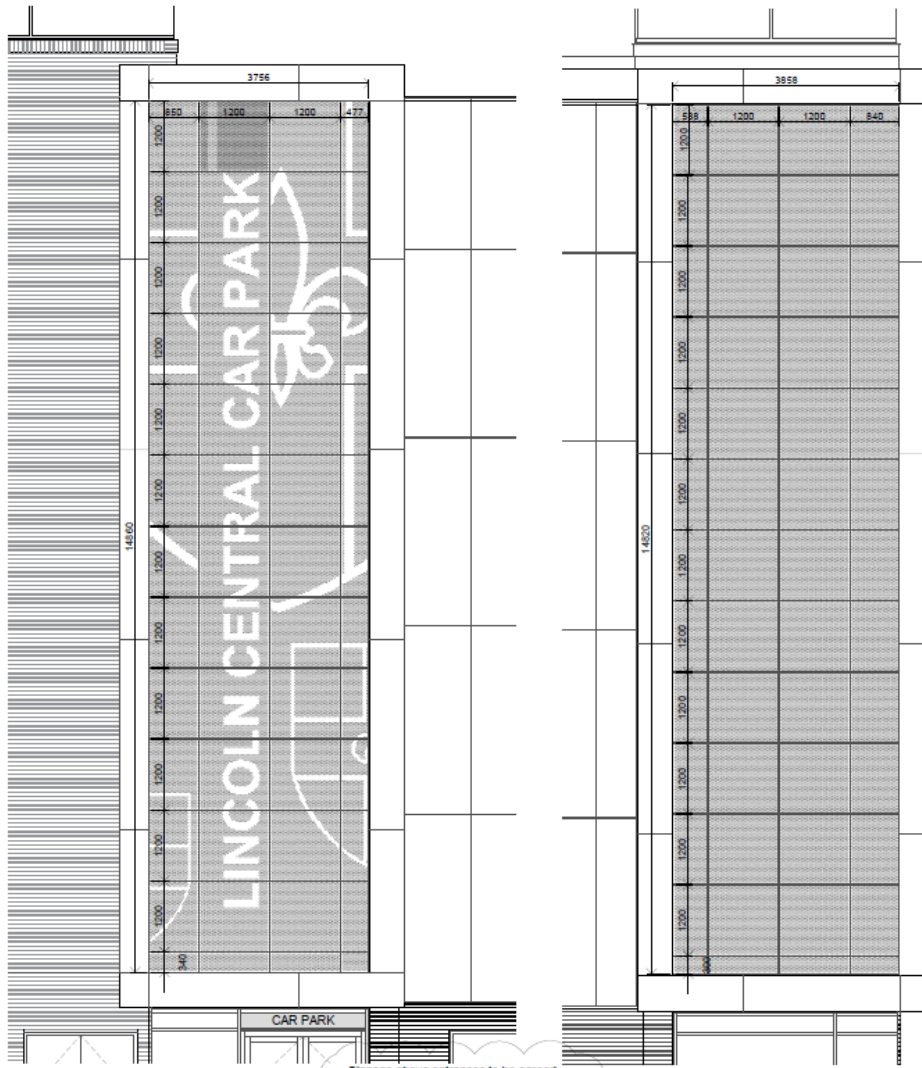

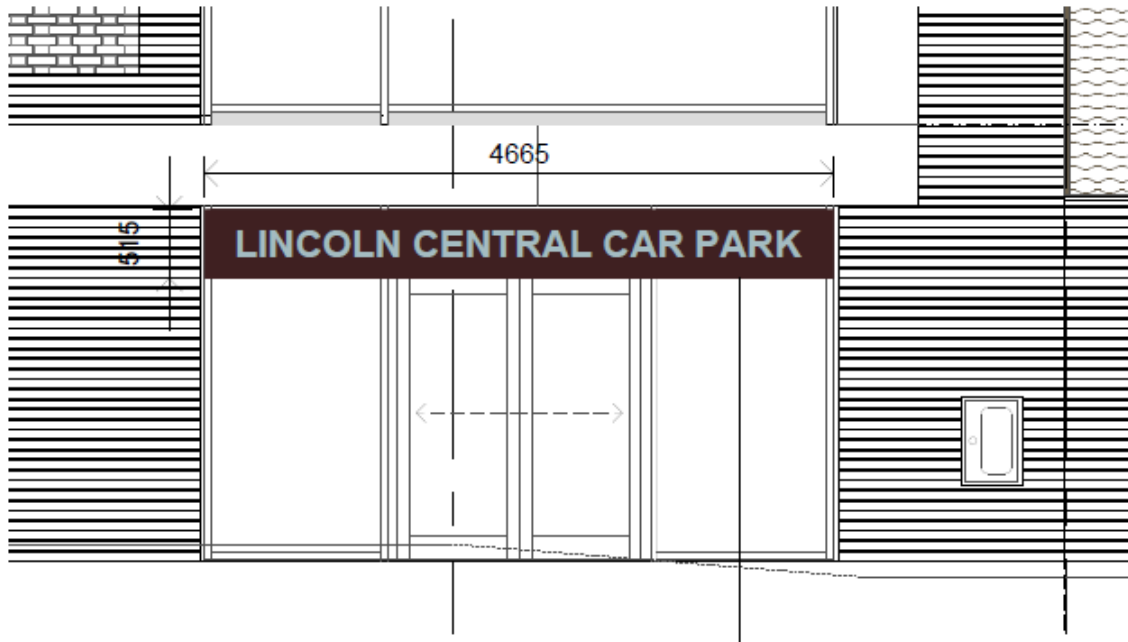

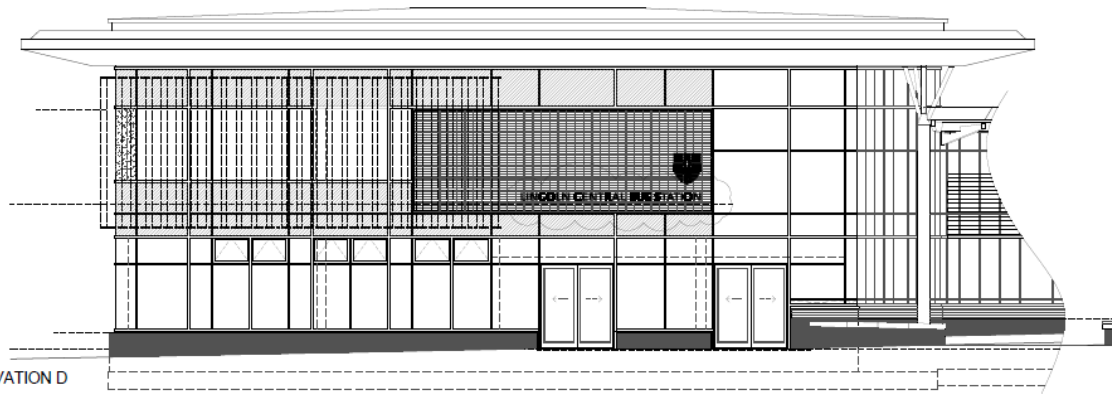

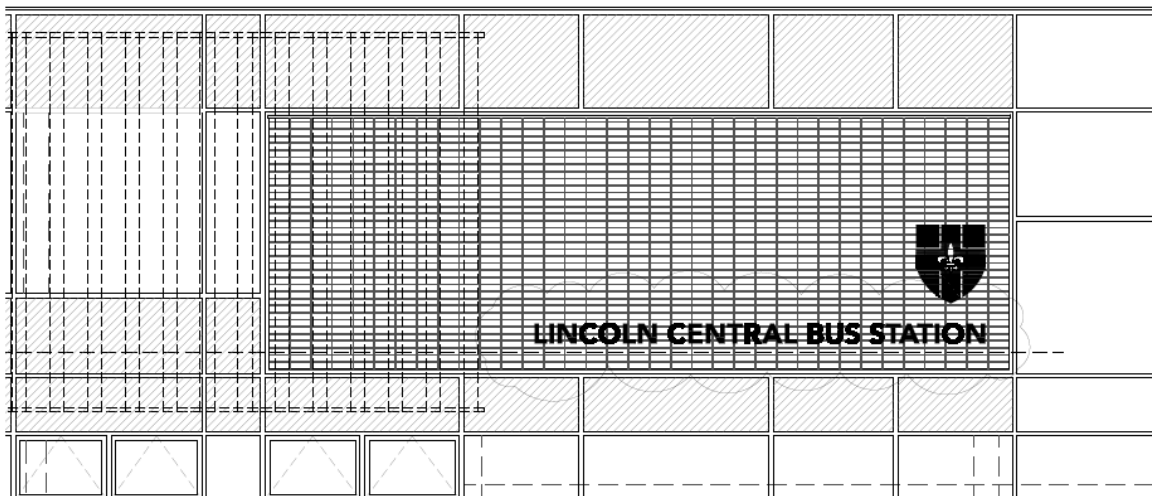

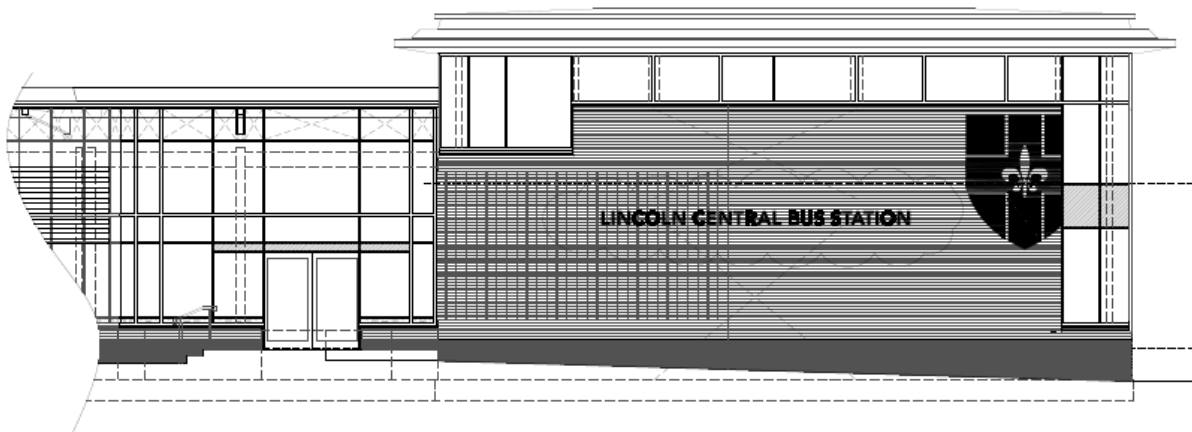

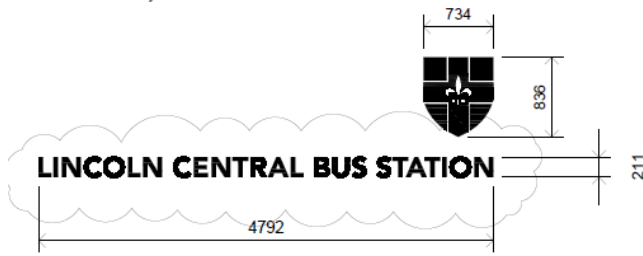

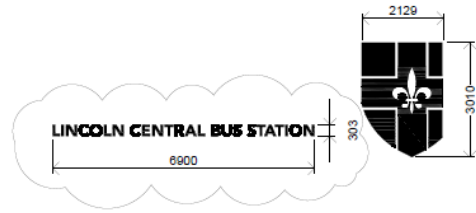
