17 Queens Crescent Lincoln Lincolnshire LN1 1LR (Objects)

I strongly object to the planned change of use of property 12 Queens Crescent from flexible dwelling (C3) and HMO (C4) to use as children's care home (C2).

- 1. Change of character of the neighbourhood.
- 2. Parking
- 3. Suitability of the property for intended use after change
- 1. This is a quiet residential neighbourhood, and use of the property as a carehome would significantly change the character of the neighbourhood to mixed use, including commercial businesses. The proposed children's care home will cause a substantial increase in traffic catering for the needs of this type of accommodation, such as professional services in addition to the residential carers, transportation of children to and from external activities, and various types of deliveries, basically similar to supplying a business.

It appears obvious that the applicants are attempting to shore up their gains from the property from the transient HMO occupation, which already disrupts the neighbourhood - without previous experience or evidence of good practice in caring for vulnerable children. This poses a risk for the underage occupants but also the local community.

Parking is already an intolerable problem in this street with a larger number of permits in circulation than spaces available, which is due to the number of HMOs, often with several cars per property. Permit holding residents can often not find any parking spaces in the zone, especially after 6pm when restrictions are no longer enforced. The stated parking requirements for the proposed change (3-5 carers, likely travelling by car, depending on staffing rota as per planning application) not only increase this situation but do exceed the permissable number of permits of 2 available for this property.

- 3. It is unclear if the proposed occupancy of up to 4 children plus residential carers (3-5 according to the staff rota) complies with or exceeds the legal occupation of this property. In addition, there are no outdoor play areas for the children, which did exist before an extension was added to the rear of the property.
- 4. In addition, allowing conversion to C2 will create a pecidence for the owner to do the same with number 14, which would be further detrimental to the character of the neighborhood for the reasons stated above.
